Stand with Haiti: The Challenge

- PIH-Haiti (aka Zanmi Lasante) partnership University Hospital of Mirebalais provides care for 3.5 million people (1/3 of Haiti's population)
- Lowest HIV rates in PIH-supported areas
- Government has not invested in health sector; <4% of budget
- Major PIH funder, PEPFAR, is cutting \$1 million in funding next year; this funding goes to many important programs for over 10,000 HIV patients



Global Fund (GFATM)

- The Global Fund to Fight AIDS, Tuberculosis and Malaria (The Global Fund) is a multilateral financing agency created in 2002
- Since then, \$50 billion dollars has been transferred from donor countries to help prevent 27 million unnecessary deaths in over 120 countries.
- The U.S. is the Global Fund's largest single donor
- U.S. support for the Global Fund has always been bipartisan

Global Fund: Our Ask of Congress


- Global funding goal is \$18 billion in the next 3-year period, U.S. funds maximum of one-third
- We want the House and the Senate to commit to a \$2 billion investment for each FY20 and FY21.
 - o FY20 runs October 2019 to September 2020
- How your members can support: submit an appropriations request form to Senators Graham and Leahy, or Representatives Lowey and Rogers, the Chairs and Ranking Members of the State and Foreign Operations Subcommittees of Appropriations.




Bilateral TB Funding

- TB is preventable and curable
- TB is the leading infectious killer in the world
- 4,900 TB deaths globally each day
- 234,000 children died of TB last year

Tuberculosis Deaths






Bilateral TB Funding: Our Ask

- Current funding is \$309 million each year
- Ask members for \$400 million in TB funding in the FY20, FY21 budget



Universal Health Coverage



U.S. alone spends \$3.5 T on healthcare each year

An increase of \$3.9 T by 2030 in health systems strengthening could prevent

97 million premature deaths.

3 Points to Teach your Member of Congress

- 1. PROBLEM: Currently at least half of the world's population lacks access to essential health services
- 2. PROBLEM: Out-of-pocket expenses drive almost 100 million people into poverty each year
- 3. SOLUTION: Additional funding is needed to supply quality care for all and protect people from financial risk.
