





Why Focus on History?


- Address health inequities and preventable deaths via healthcare delivery efforts (i.e. MCOE)
- AND, we need a larger analysis of history and economics to understand why these problems came to be and persist, and to address systemic and structural causes.



Slave Trade and British Colonial Rule

- Transatlantic slave trade
- Colonial rule: British banned Black doctors from the colonial medical service after 1902
- No nursing school in Sierra Leone until 1964, several years after independence
- No medical school until 1988.

Dr. Dibba: Only one doctor remains working in a rural area out of 10 medical graduates in my year from the single medical school (COMAHS) in Sierra Leone. # of medical doctors, nurses and midwives per 10,000 people

Structural adjustment and resource extraction

- Material disparities
- Lack of medical and nursing education (in addition to primary, secondary)
- Distrust of foreign and government institutions







PIHE Theory of Change

- US residents taking collective action can have a real impact on Congress
- Congress controls massive funding that can strengthen health systems and support a more just COVID response globally
- As we grow and increase our network's capacity, we can amplify our impact on Congress



Our Strategy and Tactics

- **Strategy:** build relationships and power to influence congressional offices
- **Tactics:** Meetings with congress members, call-a-thons/write-a-thons, LTEs, direct action, etc!

In the 2021-22 campaign year, we will generate congressional support to pass legislation that strengthens health systems toward equity.




Team-level Advocacy Goals

- Build relationships with 3+ Members of Congress
 - In a congressional relationship, teams should be able to expect responsiveness from 1 or more MoC staffers
- Grow team's advocacy capacity as measured by increased actions from year-to-year and as the campaign year progresses:
 - Calls/letters to congressional offices
 - Meetings with congressional offices
 - Letters to the Editor submitted & published
 - Other advocacy tactics

NOVID Summary

"<u>N</u>ullifying <u>Opportunities</u> for 5 <u>Variants</u> to <u>Infect</u> and <u>D</u>isseminate Act"

- Appropriating \$25 billion to fund the rapid scale-up of mRNA COVID-19 vaccines to produce 8 billion doses within approximately one year to meet global needs
- Working with our international partners to purchase enough vaccines for low- and middle-income countries to immunize at least 60% of their populations.
- 3. Appropriating \$8.5 billion to support end-to-end delivery and administration of COVID-19 vaccines in low- and middle-income countries. The Program should be modelled off of the President's Emergency Plan For AIDS Relief (PEPFAR), which has for almost two decades set the global standard for targeted bilateral public health interventions.
